EXPLANATORY STATEMENT

The Board of Fire Commissioners, Moorestown Township Fire District No. 2, has decided that there is a need to purchase a Taylor'd Prop. This piece of equipment will allow members to practice and train at the firehouse on a multitude of roof configurations as well as forcible entry, window ventilation, firefighter rescue, ceiling ventilation, confined space rescue, hose management, Mayday training, garage door simulation, wall breach and ladder work. This will allow more frequent training opportunities without having the expense of traveling to far away training grounds.

Money for the prop has been saved over the years and placed in Reserve for Future Capital Outlays. No money will need to be borrowed to purchase the prop.

A "yes" vote will authorize the Board of Commissioners of the fire district to place the above amount in the 2025 Fire District Budget to purchase the Taylor'd Prop as listed.
